REGULATIONS OF THE NORTH POLE EXPEDITION "ICEBREAKER OF KNOWLEDGE 2025"

These regulations set out the terms and procedures governing the North Pole expedition "Icebreaker of Knowledge 2025," including the terms and conditions for participation.

The primary aim of the Expedition is to deliver educational activities focused on the nuclear industry, for the participants meeting the eligibility criteria (hereinafter referred to as "Participants"). Participation in the Expedition is non-remunerated and should not be considered a source of income. It is an educational initiative designed to promote the achievements of the nuclear industry, encourage scientific inquiry, and inspire intellectual engagement among young people. The Expedition also seeks to foster a deeper interest in science, technology, and innovation.

By taking part in the Expedition, all Participants confirm that they have read, understood, and agree to comply fully with these regulations (hereinafter referred to as "the Regulations").

1. GENERAL PROVISIONS

- 1.1. Official Name of the Expedition: The North Pole Expedition "Icebreaker of Knowledge 2025" (hereinafter referred to as "the Expedition").
- 1.2. The geographical scope of the Expedition is the entire territory of the Russian Federation and the international waters of the Arctic Ocean.
- 1.3. The Expedition is organised by: Autonomous Non-Commercial Organisation "Nuclear Industry Information Centre" (abbreviated as ANO NIIC), INN (Taxpayer Identification Number): 7726372266, KPP (Tax Registration Reason Code): 770201001, registered address: 57 Gilyarovskogo St., Structure 4, Premises I, Floor 7, Moscow, Russian Federation 129110 (hereinafter referred to as "the Organiser" or "the Expedition Organiser").
- 1.4. Expedition Route: Murmansk North Pole Murmansk.
- 1.5. The Expedition will be conducted aboard the nuclear-powered icebreaker "50 Let Pobedy" (hereinafter referred to as "the Icebreaker").
- 1.6. The Expedition Organiser reserves the right to appoint co-organisers to assist in the planning and delivery of the Expedition. Co-organisers are legal entities duly registered under the laws of the Russian Federation and actively involved in the logistical, educational, or operational aspects of the Expedition (hereinafter referred to as "Co-organisers").
- 1.7. Expedition Dates:

The Expedition is scheduled to run from 13 August 2025 to 22 August 2025, inclusive.

1.8. In case the Expedition cannot be carried out or its dates (conditions) are rescheduled due to reasons beyond the control of the Organiser, including but not limited to force majeure circumstances, natural disasters, decisions by local government authorities and/or federal authorities to introduce quarantine measures, regional closures, political events, decisions made by the organisation responsible for the operation and maintenance of the atomic icebreaker fleet, the Participants will be additionally informed by the Organiser or Co-organisers.

2. PREPARATION FOR THE EXPEDITION

2.1. All participants are required to submit a complete the following set of documents prior to the commencement of the Expedition, depending on the participant's age and citizenship status:

2.1.1. For Minors (Under 18) who are Citizens of the Russian Federation:

- a valid identity document (internal passport of a Russian citizen, required for individuals aged 14 and over);
- a copy of the parent or legal guardian's identity document (Russian citizen's passport); a copy of the document confirming legal relationship with the Participant (e.g., birth certificate) or official documentation confirming legal guardianship or representation (in cases where someone other than a parent is acting on the Participant's behalf);
- a valid compulsory health insurance policy (OMS);
- written consent from the parent or legal guardian for the processing of the Participant's personal data, as well as the personal data of the parent or legal guardian, completed in accordance with Form No. 1 attached to these Regulations;
- written consent from the parent or legal guardian for photo, video, and audio recording during the Expedition, and for the subsequent publication and use of such materials, completed in accordance with Form No. 2;
- notarised consent from the parent or legal guardian permitting the minor to take part in the Expedition, specifying the Expedition dates, completed in accordance with Form No. 3;
- a certificate from the educational institution confirming the Participant's current enrolment;
- complete medical documentation as specified in the List of Required Medical Documents for Participation in the Expedition (Appendix No. 1 to these Regulations).

2.1.2. For Adult Participants (18 Years and Over) who are Citizens of the Russian Federation:

- a valid internal passport of a Russian citizen;
- a valid compulsory health insurance policy (OMS);
- written consent for the processing of the Participant's personal data, completed in accordance with Form No. 4 attached to these Regulations;
- written consent from the Participant for photo, video, and audio recording during the Expedition, and for the subsequent use of such materials, completed in accordance with Form No. 5;
- complete medical documentation as specified in the List of Required Medical Documents for Participation in the Expedition (Appendix No. 1 to these Regulations).

2.1.3. <u>For Adult Foreign Participants (defined as individuals who are aged 18 or over by 01 August 2025):</u>

- a valid foreign passport (or other official identity document recognised by the Russian Federation for the purpose of entry and identification), accompanied by a valid Russian visa, unless exempt under applicable international treaties, Federal Law, or Presidential decrees of the Russian Federation;
- proof of comprehensive travel insurance covering the Participant for risks to life and health throughout the entire duration of the Expedition;
- complete medical documentation as specified in the List of Required Medical Documents for Participation in the Expedition (Appendix No. 1 to these Regulations);
- written consent for the processing of the Participant's personal data, completed in accordance with Form No. 4 attached to these Regulations;
- written consent from the Participant for photo, video, and audio recording during the Expedition, and for the subsequent use of such materials, completed in accordance with Form No. 5.

2.1.4. For Minor Foreign Participants (defined as individuals aged 14 to 18):

- A valid foreign passport (or other official identity document recognised by the Russian Federation for the purpose of entry and identification), accompanied by a valid Russian visa, unless exempt under applicable international treaties, Federal Law, or Presidential decrees of the Russian Federation;
- proof of comprehensive travel insurance covering the Participant for risks to life and health throughout the entire duration of the Expedition;
- complete medical documentation as specified in the List of Required Medical Documents for Participation in the Expedition (Appendix No. 1 to these Regulations);
- written consent from the parent or legal guardian for the processing of the foreign Participant's personal data, as well as the personal data of the parent or legal guardian, completed in accordance with Form No. 1 attached to these Regulations;
- written consent from the parent or legal guardian of the foreign Participant for photo, video, and audio recording during the Expedition, and for the subsequent use of such materials, completed in accordance with Form No. 2;
- notarised consent from the parent or legal guardian permitting the Participant to take part in the Expedition, specifying the Expedition dates, completed in accordance with Form No. 3, accompanied by a notarised Russian translation if the original is in another language.
- 2.1.5. The Expedition Organiser and Co-organisers reserve the right to request any additional documentation relating to a Participant's health status if deemed necessary for the safe and effective management of the Expedition.
- 2.2. At the time of submitting the required documents, parents or legal guardians must inform the Organiser or relevant Co-organiser (whichever is responsible for supervision during the Expedition) in writing of any medical or health-related conditions affecting the Participant, including but not limited to: special dietary requirements, fluid intake regimes, known allergies or allergic reactions, chronic illnesses, conditions prone to sudden exacerbation, any recurring or significant health issues; a detailed, hour-by-hour schedule of all medications the Participant is required to take, including dosage, frequency, and method of administration; along with the full supply of prescribed medications needed for the entire duration of the Expedition. The Organiser or Co-organiser may, at any time, request a formal medical report for the Participant. Parents or legal guardians are also obliged to disclose any knowledge of: harmful habits (including alcohol consumption, tobacco use, or substance use by the Participant); behavioural or psychological conditions, including but not limited to any history of suicidal thoughts or tendencies.
- 2.3. Upon handing over the Participant to the authorised representative of the Organiser or Co-organiser (as applicable), parents or legal guardians must provide all necessary medications and medical devices used by the Participant listed in Section 2.2 of these Regulations, as required for the full duration of the Expedition, including transfer days.
- 2.4. The following conditions constitute contraindications for participation (grounds for non-admission to the Expedition):
- acute illnesses at the time of departure;
- any medical conditions requiring continuous supervision by a qualified physician;
- chronic illnesses currently in an acute or unstable phase;
- injuries resulting in impaired mobility or motor function;
- conditions that could deteriorate and necessitate emergency medical intervention or evacuation to a shore-based medical facility;
- congenital or acquired physical disabilities significantly affecting mobility or self-care;
- mental health disorders.

Parents or legal representatives are required to inform the Organiser or the relevant Co-organiser of any medical contraindications affecting the Participant, as listed in these Regulations. Failure to disclose known contraindications may result in the Organiser or Co-organiser seeking full reimbursement from the parents or legal guardians for all costs incurred as a direct consequence, including but not limited to emergency evacuation of the Participant. If the Organiser or Co-organiser has reasonable concerns about a Participant's health or fitness to take part (based on observed behaviour, incomplete documentation, or

inconsistent information) they reserve the right, at their sole discretion, to request additional medical documentation from a medical institution, and/or to exclude the Participant from the Expedition.

2.5. All Expedition Participants must bring a complete set of suitable clothing and personal items for life aboard the icebreaker and for outdoor activities in extreme Arctic conditions: daily wear items for approximately 10 days (a small surplus is advised) – t-shirts, trousers, socks, underwear, warm jumpers or sweaters, sleepwear; closed-heel indoor shoes with non-slip soles (smooth soles are not permitted), slippers (for cabin or shower use only).

Participants must be properly equipped for deck and outdoor activities: warm socks, warm trousers, wool jumper or equivalent (e.g., fleece jacket), thermal base layers (top and bottom), hat, mittens or gloves, waterproof winter boots with deep, non-slip treaded soles, heavy-duty winter jacket, sunglasses.

- 2.6. Participants are to arrive at the designated departure point (location and time confirmed in advance by the Organiser or Co-organiser), accompanied by designated attendants appointed by the Organiser or Co-organiser. Accompanying staff must carry the following at the time of handover: a complete list of the Participants they are responsible for; all required authorisations from parents or legal guardians; copies of all documents stipulated in these Regulations, particularly for minor Participants.
- 2.7. For Russian citizens arriving on the day of departure in accordance with the established procedure, a boarding manifest will be prepared for entry onto the Icebreaker. This document permits single entry and single exit, and includes verification of personal details, official record of border clearance, as administered by the authority responsible for the operation and maintenance of the nuclear icebreaker fleet. The following personal information is required for each Participant to issue the manifest: Full name, sex, date and place of birth, passport details, citizenship (see Appendix No. 2 to these Regulations). Co-organisers must submit the completed manifest (in accordance with Appendix No. 2 to these Regulations) to the Organiser no later than three calendar weeks (21 days) before the scheduled start date of the Expedition.
- 2.8. For foreign Participants, a technical assignment for the admission of foreign nationals must be prepared in advance. The information required is detailed in the table provided in Appendix No. 3 to these Regulations. Co-organisers must submit the completed technical assignment for the admission of foreign nationals (in accordance with Appendix No. 3 to these Regulations) to the Organiser no later than ten (10) calendar days before the scheduled start date of the Expedition.
- 2.9. All electronic devices and valuable personal property brought aboard the icebreaker must be declared through a unified material pass (entry/exit pass) issued by the organisation responsible for the operation and maintenance of the nuclear icebreaker fleet. The Organiser or relevant Co-organiser must provide a detailed list of such items, including brand and model names and serial numbers or other identifying marks. The Co-organiser must notify the Organiser of the need to declare any personal equipment or valuables no later than three weeks (21 days) before the start of the Expedition.
- 2.10. During the Expedition, participants are required to abide by these Regulations, the internal rules and directives of the organisation responsible for the operation and maintenance of the nuclear icebreaker fleet, instructions issued by accompanying staff appointed by the Organiser or Co-organiser, orders from officials of the organisation responsible for the operation and maintenance of the nuclear icebreaker fleet, directions given by the Icebreaker crew, and the applicable legislation of the Russian Federation.

3. ACCOMMODATION ON BOARD THE ICEBREAKER, MEALS AND MEDICAL SUPPORT

- 3.1. Participants are accommodated in shared cabins, two (2) Expedition Participants per cabin, in accordance with the following criteria:
- Minors (under 18 years of age) must not share a cabin with adults;
- Participants of different sexes are not permitted to share the same cabin;
- Priority is given to pairing Participants of similar age (within one to two years of each other) who speak the same language, to ensure comfort and effective communication.

- 3.2. Each cabin is equipped with a single bed for each Participant, complete with bed linen, pillow, and blanket, and an en-suite bathroom with shower, towels, soap, toilet paper, and shampoo. Bed linen changed at least twice during the Expedition, and towels are replaced daily. Daily cleaning service is provided. Each cabin is equipped with 220V power outlets. Each deck has a water cooler providing drinking water.
- 3.3. Meals for Expedition Participants are served in the dining hall using a buffet system. Throughout their participation in the Expedition, Participants receive five (5) child-appropriate meals per day, except on the first and final days, when meal provision will depend on the timing of departure and arrival. Catering is organised in full compliance with current Russian legislation, state standards, technological regulations, industrial sanitation rules, SanPiN requirements, labour protection regulations, and all other applicable legal and regulatory frameworks governing public catering establishments.
- 3.4. The Icebreaker is equipped with a range of facilities, including a dining hall, a library, a medical office, a gymnasium, a lecture hall, passenger cabins and technical areas.
- 3.5. A medical office is maintained on board with a medical specialist on duty at all times, available around the clock.
- 3.6. During the Expedition, two (2) medical professionals are present on the vessel. Both hold relevant medical qualifications and possess substantial professional experience, including in working with minors. These medical staff are employees of the Federal Medical-Biological Agency of Russia.
- 3.7. The medical office is outfitted with modern medical equipment and a comprehensive supply of medications to provide emergency and urgent care to Participants as needed. Measures are in place throughout the Expedition to maintain a strict anti-epidemic regime on board, aimed at preventing the spread of infectious diseases on board the Icebreaker.
- 3.8. In addition, continuous consultative medical support is provided via satellite communication by a shore-based medical institution—the Federal State Budgetary Healthcare Institution "N.I. Pirogov Murmansk Multidisciplinary Centre" of the Federal Medical-Biological Agency.

4. RULES OF CONDUCT ON BOARD THE ICEBREAKER

- 4.1. Expedition Participants must remain vigilant and exercise the highest level of care and caution at all times throughout the journey. All Expedition Participants are required to comply with instructions issued by the Icebreaker crew members and accompanying personnel at all times. On the first day of the Expedition, a mandatory safety briefing will be conducted on board the Icebreaker for all Participants.
- 4.2. All movement on the Icebreaker must be carried out exclusively under the supervision of designated accompanying persons or authorised representatives of the Icebreaker crew. Participants are not permitted to move independently anywhere on the vessel.
- 4.3. Should any questions or concerns arise during the Expedition, Participants must address them directly to accompanying staff or the Icebreaker crew members.
- 4.4. Participants are expected to treat all property on board the Icebreaker with care and responsibility.
- 4.5. Respectful behaviour towards fellow Participants, accompanying personnel, and crew members is mandatory at all times.
- 4.6. Participants are required to attend all scheduled activities and events throughout the Expedition.
- 4.7. Any symptoms of illness or discomfort must be reported immediately to accompanying staff or a member of the medical or crew team.
- 4.8. Participants must adhere strictly to the established schedule for sleep and rest as set by the Organiser.
- 4.9. Clothing and footwear should be chosen with safety and comfort in mind. While slippers or flip-flops may be worn inside the cabin or when using the shower, weather-appropriate closed-heel shoes with non-slip soles must be worn at all other times. Each Participant is responsible for selecting appropriate clothing and footwear suitable for the Arctic environment and onboard conditions. Accompanying staff or crew members reserve the right to restrict a Participant's movement if their attire is deemed unsuitable or unsafe for prevailing conditions.

- 4.10. When moving about the vessel, Participants must exercise caution and follow the "three points of contact" rule, ensuring that two feet and one hand, or two hands and one foot, are always securely in contact with handrails or stable surfaces.
- 4.11. The use of personal sports equipment on board is strictly prohibited unless prior permission has been granted by accompanying personnel or the Icebreaker crew.
- 4.12. Running is not permitted anywhere on the Icebreaker. Movement throughout the vessel may only take place as part of an organised group under the supervision of authorised staff.
- 4.13. The placement of large personal items outside designated storage areas is not allowed.
- 4.14. It is strictly forbidden to bring animals on board.
- 4.15. The possession or consumption of alcoholic beverages, tobacco products, or narcotic substances is prohibited.
- 4.16. Participants must not board the Icebreaker under the influence of alcohol or drugs, and such states during the Expedition will not be tolerated.
- 4.17. Smoking, including the use of e-cigarettes, vapes, and similar devices, consumption of alcohol or drugs is completely banned on board.
- 4.18. Throwing any objects overboard is strictly prohibited.
- 4.19. Food must not be removed from designated dining areas.
- 4.20. Noise must be kept to a minimum during designated rest and sleep hours to ensure the comfort of all on board.
- 4.21. Access to service areas, the engine room, the hold, and other restricted technical compartments is strictly forbidden.
- 4.22. Participants must not lean over, climb on, or hang from the bulwarks or guard rails at any time.
- 4.23. Tampering with or operating any shipboard mechanisms, switches, or technical equipment, such as turning systems on or off, is strictly prohibited.
- 4.24. Feeding wildlife is not allowed during any encounters or observation activities.
- 4.25. When on the navigating bridge, Participants must remain on the starboard side as directed.
- 4.26. Before leaving their cabin, Participants must ensure that all electrical appliances and lights are switched off and that water taps are fully closed.
- 4.27. Photography and video recording, including the use of mobile phones and personal devices, are not permitted in or near the premises of the organisation responsible for the operation and maintenance of the nuclear icebreaker fleet. Such activities may only be carried out with prior written authorisation from the organisation responsible for the operation and maintenance of the nuclear icebreaker fleet.
- 4.28. The following items are strictly prohibited from being brought onto the premises of the organisation responsible for operation and maintenance of the nuclear icebreaker fleet, including on board the Icebreaker:
- bladed weapons or firearms, ammunition, and explosives;
- toxic, radioactive, or chemically active substances;
- flammable liquids;
- incendiary materials and devices;
- personal protection or offensive equipment such as pepper spray, traumatic pistols, or gas pistols;
- narcotic substances;
- alcoholic beverages, including beer and alcoholic cocktails;
- drones, recording devices, or similar technical equipment (media representatives requiring such equipment must follow a separate registration procedure).
- 4.29. For operational and security reasons, any filming, video recording, or photography (hereinafter referred to as "shooting") conducted in the vicinity of, or on the premises of, the organisation responsible for operation and maintenance of the nuclear icebreaker fleet is permitted only with the prior written authorisation of the organisation's authorised representatives, upon submitting a complete set of required applications:

- For conducting the photography/videography;
- For carrying the photographic or video equipment intended for shooting;
- And in strict accordance with a prearranged and officially approved schedule of the planned activity.
- 4.30. In addition to these requirements, specific rules and restrictions may be imposed by the organisation responsible for operation and maintenance of the nuclear icebreaker fleet, applicable both on board the Icebreaker and within or near the Expedition departure and arrival zones. These additional measures are binding on all Expedition Participants. Compliance with all such rules is mandatory.

5. PROCEDURE FOR PROCESSING AND STORING PERSONAL DATA OF EXPEDITION PARTICIPANTS

5.1. By taking part in the Expedition, each Participant consents to the processing and storage of their personal data by the Organiser for the purposes of organising and conducting the Expedition. The Organiser confirms that all personal data provided by Participants will be processed and stored in full compliance with the current legislation of the Russian Federation.

Every Participant has the right to withdraw their consent to the processing of their personal data, either in full or in part, by submitting a written notification to the Organiser at the following address: 57 Gilyarovskogo St., Structure 4, Moscow, 129110. However, withdrawal of consent for personal data processing renders continued participation in the Expedition impossible. In such cases, the Organiser reserves the right to exclude the Participant from the Expedition. Upon receiving a notification from an Expedition Participant regarding the withdrawal of consent to the processing of personal data, the Organiser is obliged to cease processing such data and ensure the cessation of such processing by any party acting on behalf of the Expedition Organiser. Furthermore, if the retention of personal data is no longer necessary for the purposes of personal data processing, the data should be destroyed or its destruction ensured (if the processing is carried out by another party acting on behalf of the Organiser) within a period not exceeding 30 (thirty) calendar days from the date of receipt of such notice. This excludes cases where the Organiser is entitled to process personal data without the consent of the data subject under the grounds provided by Federal Law No. 152-FZ dated 27.07.2006 "On Personal Data" (hereinafter referred to as the Personal Data Law) or other federal laws.

- 5.2. By participating in the Expedition, the Participant and their parent or legal guardian consent to the processing of the following personal data of the Expedition Participant/their parent or legal guardian: surname; first name; patronymic; passport series, number, date of issue, and issuing authority, including subdivision code; date of birth; grade, course or year of study, and the name of the educational institution attended; place of birth; place of residence or temporary stay of the Participant; phone number; email address; health information, and other information submitted in documents to the Organiser, as well as the Expedition Participant's image (including video image), for the organisation's purposes and for organising and conducting the Competition.
- 5.3. The Organiser reserves the right to disclose the following details about Expedition Participants: surname, first name, and patronymic, and to publish their image (including video images) in materials related to the organisation and publication of the Expedition on the Internet.
- 5.4. The processing and/or distribution of personal data will be carried out by the Organiser and/or other partners engaged by the Organiser acting on behalf/instruction of the Organiser, in compliance with the principles and rules provided for by the Personal Data Law.
- 5.5. For the purposes of these Regulations, "personal data" refers to the information relating to Expedition Participants and/or their parents or legal guardians, as defined under the Personal Data Law. Processing of personal data in these Regulations refers to any action (operation) or a set of actions (operations) performed using automated means or without such means on personal data, including collection, recording, systematisation, accumulation, storage, updating (modification, alteration), retrieval, use, transfer (dissemination, provision, access), anonymisation, blocking, deletion, destruction of personal data provided by each Participant for the purpose of conducting the Expedition.

- 5.6. The Organiser and any partners acting on its behalf or at its instruction undertake to comply with the following obligations and provide the following guarantees to each Expedition Participant regarding the handling of personal data:
- to ensure that all processing of personal data is carried out in accordance with the applicable provisions of Russian legislation on personal data protection, including adherence to the principles, requirements, and responsibilities set out for data operators under the Personal Data Law.
- to process personal data solely to the extent necessary and strictly for the purposes of organising and conducting the Expedition. Any use of personal data for additional purposes, such as informing individuals about products or services, will only be carried out where permitted by the Personal Data Law and with appropriate legal grounds;
- in cases where the Organiser or its partners must transfer or otherwise disclose personal data to third parties in order to fulfil their obligations to the Expedition Participants, such disclosure will be made in compliance with the requirements of the Personal Data Law.
- to take full responsibility for protecting the confidentiality, security, and integrity of the personal data of Expedition Participants throughout the entire processing lifecycle, in line with the standards and safeguards required by Russian law.

6. FINAL PROVISIONS

- 6.1. For all matters not expressly covered by these Regulations and the Rules governing the "Icebreaker of Knowledge 2025" educational project, specifically those relating to the participation of Competition winners in the Expedition, the Organiser and Co-organisers shall refer to the applicable legislation of the Russian Federation.
- 6.2. Any Participant who is late, fails to appear for departure, or does not have a complete and properly prepared set of required documents will forfeit their right to take part in the Expedition. In such cases, no compensation will be provided, and the Participant or their representatives shall have no grounds to claim damages or penalties against the Organiser or any Co-organiser.
- 6.3. The Participants will not be accompanied by their parents or legal guardians during the Expedition.
- 6.4. The Co-organiser responsible for dispatching Participants must either ensure that qualified accompanying personnel are present in the number and capacity required by Russian legislation, or formally request such accompaniment from the Organiser no later than three calendar weeks prior to the start of the Expedition. Co-organisers dispatching Participants are responsible for arranging and covering, at their own expense, accommodation, meals, and transportation for Participants travelling to the point of departure and from the point of return to their permanent place of residence. In the event that the Expedition is cancelled or rescheduled (as outlined in Section 1.8 of these Regulations), the Co-organiser shall not be entitled to claim compensation for any costs already incurred.
- 6.5. If a Participant is unable to take part in the Expedition for any reason, the Participant, or their parents or legal representatives, shall not be entitled to any financial compensation or reimbursement, except in cases explicitly provided for in these Regulations.
- 6.6. All expenses related to obtaining the necessary documents and carrying out any actions required for participation in the Expedition, including medical checks, visas, insurance, and travel, are the sole responsibility of the Participant and their parents or legal guardians. The Organiser does not reimburse any of these costs.
- 6.7. All documents of the Expedition Participant's parent or legal guardian as required by these Regulations must be provided by the parent or legal guardian of the Participant signing the documents on behalf of the Expedition Participant.
- 6.8. The Organiser reserves the right to amend these Regulations at any time prior to the start of the Expedition. Any changes will be published in a new version of the Regulations on the official project website: https://polus.atom.online/.

- 3. Medical certificate (Form 079/U) confirming the individual's health status for participation in educational and recreational programmes. This certificate must be issued no more than three months before the start of the Expedition.
- 4. Result of a lung X-ray or fluoroscopy (valid for up to two years), or a Diaskintest (valid for up to 12 months), accompanied by an official conclusion from a qualified phthisiologist confirm the absence of tuberculosis. - 2. Certified copy of vaccination records (Form 063/u).
- 3. Medical certificate (Form 079/U) confirming the individual's health status for participation in educational and recreational programmes. This certificate must be issued no more than three months before the start of the Expedition.
- 4. Certificate of oral cavity sanitation, issued by a dental professional no more than 10 days before the start of the Expedition.
- 5. Result of a Diaskintest (valid for up to 12 months), or an official conclusion from a qualified phthisiologist confirm the absence of tuberculosis. The conclusion must be printed on official letterhead, bearing the institution's seal, the doctor's signature, and personal stamp.
- 6. Certificate confirming no recent contact with infectious diseases, issued no more than 72 hours before check-in. It is recommended that this document be obtained and submitted on the final day before departure from home.

! All medical documents must be issued on the official letterhead of the relevant medical institution and include the organisation's seal, and the attending physician's official stamp and signature. Participants must bring the original documents with them to the Expedition.

For Foreign Citizens:

- 1. A medical report confirming the absence of acute illnesses or exacerbations of chronic conditions, issued no more than 14 days prior to arrival.
- 2. Details of any illnesses, injuries, or surgical procedures experienced within the past 12 months.

- 3. Comprehensive information on any existing chronic diseases.
- 4. Information on any medical conditions that could pose a risk to the individual's life or health, or to the health and safety of others during the Expedition.
- 5. Information on any ongoing medication, including the medical indication, name of the drug, dosage, and administration schedule.
- 6. Evidence of recent tuberculosis screening: either a chest X-ray or Diaskintest, conducted within the last 12 months.
- 7. Proof of vaccination against diphtheria, tetanus, measles, rubella, hepatitis B, poliomyelitis, as per national immunisation schedules.

Procedure for Admitting Participants to the Vessel.

Before boarding the vessel, a paediatrician will carry out a thorough review of the Participant's medical documentation; a consultation to identify any current health complaints, and a physical examination to detect signs of acute illness or an exacerbation of a chronic condition.

Based on the results of this check, a group of participants may be identified for dynamic observation during the initial phase of the Expedition.
